

## What is EURIPHI - the European wide Innovation Procurement in Health and Care Project?

EURIPHI is an EU initiative (funded by H2020) that aims to create a Europe-wide community of public procurers and procurement organizations in the health and social care sector which aims to address common unmet needs and shortcomings in the current care delivery by using innovation procurement to implement innovation and integrated care innovative solutions using a 'Public procurement of innovative solutions' (PPI) or 'Pre-commercial procurement' (PCP). Open, restrictive as well as innovation partnerships tendering procedures will be applied in conformity with national legislation.

The procurement organizations involved as EURIPHI partners or members of the advisory board are interested in value-based innovation procurement and have teamed up around the novel approach of Most Economically Advantageous Tendering Value Based Procurement of Innovation Solutions (MEAT VBPPi).

EURIPHI aims by June 2020 to:

- Establish a sustainable Community of Practice using value-based innovative procurement methods;
- Adapt the existing tools, perform market consultations and deploy cross-border Value Based PPI/PCP testing as learning cases in the field of rapid diagnostics for infectious diseases and new models of patient-centred integrated care;
- Build legal guidance of a value-based cross border cooperation for innovation procurement with localized decision making;
- Build a "EURIPHI Regional Network" to prioritize areas of common interest to address unmet needs, shortcomings in care delivery and guide investment decisions.

EURIPHI aims to continuously build consortia to jointly submit to upcoming (EU) calls for innovation procurement co-financed by the EU in areas of priority using the EURIPHI Value based procurement approach.

## What is the EURIPHI Regional Network?

**An EU collaborative network of:**

- 1. representatives of (regional) health – care authorities, policymakers, chief financial officers and payers;**
- 2. with an ability to impact decisions** to foster economic sound investment to introduce innovation/innovative solutions in health and integrated care;
- 3. who, in collaboration with other key stakeholders, are willing to prioritize areas of investments and foster the deployment of Value Based PPI/PCP.**

The Network also aims to involve the Innovation (Procurement) Agencies/Responsibles in developing reflection papers. The Network is supported by a Secretariat.

## EURIPHI Network – What is in it for me?

- **Be informed on the latest innovation procurements across Europe to address unmet needs/shortcomings introduced in health and care systems through innovative procurement and initiatives leading to economically most advantageous - value driven purchasing.**

*Where from?* Participating regions/institutions, the EU and leading experts from EURIPHI and the Value Based procurement Community of Practice.

*Focus during the EURIPHI project:* Rapid diagnostics in management of pneumonia infectious disease at hospital / ICU and Integrated care and use of cross-border value driven procurement with localized decision making. *Focus after the project:* on areas of common interest, as defined in the reflection papers (see below).

- **Get access to a new approach on the “Most Economically Advantageous Tendering Value Based Procurement of Innovation Solutions (MEAT VBPPi)” that will assist you in implementing changes towards value-driven healthcare delivery. This method aims to steer towards patients-centric economic sustainability of healthcare systems.**
- **Provide insights on practices/processes used to define and prioritize shortcomings in care delivery and unmet needs to foster “good health”.**

*Initial Focus:* Patient-Centered integrated care solutions: eg. In the fields of Stroke, Aortic Stenosis, Multimorbidity, COPD, Dementia.

- **Contribute to the development of a reflection paper on the MEAT Value Based PPI as policy instrument and the legal guidance for a cross-country Value driven joint innovation procurement.**
- **Discuss cross-border collaborative cooperation**, identifying possible clusters of cooperation responding to future PPI Calls – EU Calls or investing in localized value-based Innovation procurement, innovation partnerships.

## What is expected from me if I join?

Your involvement can be either **passive or active** (with the possibility to adapt how best it suits you).

### With an active involvement:

- Foster the deployment of value-driven innovation procurement, MEAT Value-based procurement as a way forward to change procurement practices and **introduce innovation in health and social care systems of “value”** to address unmet needs/ shortcomings in current care delivery in an economically most advantageous way.
- Participate in a **survey** on the mechanisms to identify your current prioritization of “integrated care” proposals by EURIPHI.
- Participate in **three Meetings** facilitated by EURIPHI (currently aimed for June '19, October '19 and February '20);

- **Contribute to/review two papers:** 1. A descriptive paper to share current practices to identify unmet needs- by September '19; 2. A reflection paper to provide a view on the EURIPHI proposed cross-border Value driven PPI.

**With a passive involvement:** You will be invited to take part in the survey, in the review and prioritization of areas of interest and you will receive the insights.
