EURIPHI OPEN MARKET CONSULTATION - PARIS

RAPID DIAGNOSTIC INNOVATION AND SOLUTIONS FOR IN HOSPITAL INTENSIVE CARE MANAGEMENT OF PATIENTS WITH VENTILATOR ASSOCIATED PNEUMONIA (VAP).

Introduction: The EURIPHI Open Market Consultation, as part of an EU project, will provide the medical technology industry an opportunity to present rapid diagnostic innovation and solutions to manage Ventilator-Associated Pneumonia (VAP). This to multiple procurement organization, partners of EURIPHI or members of the Advisory board EURIPHI, during 1:1 session of 20-30 minutes each.

The Challenge: Since culture-based identification and susceptibility testing often takes 2-3 days, a rapid diagnostic test may be beneficial in the pathways of Ventilator Associated Pneumonia (VAP).

A focus will be given on the antibiotic stewardship of VAP by early detection of the presence of pathogens, and possible markers of antibiotic resistance to optimize treatment (de-escalation), and thus to reduce the burden of antibiotic resistance, length of stay, mortality, morbidity and the overall costs of care.

The meeting: An introductory session will highlight the focus of the EURIPHI project to foster Value-based procurement of innovative solutions and building out a community of practice and legal guidance for value based cross border procurement.

Also, the University Antwerp will present the ideal technical specifications of the diagnostic test based on the input from a number of experts proposed by the European Respiratory Society (ERS). This input will put weight factors on the various value associated outcomes and the underlying technical specifications, again bridging clinical significance to value.

The next steps: In follow-up of the 1:1 dialogues, procurement organizations will build one or several consortia and run learning procurement procedures to test out a cross border procurement of rapid diagnostics with defined levels of cooperation and localized decision/contracting. The results of the learning will be reported.

The opportunity: An opportunity to present latest innovation and engage simultaneously with multiple procurement organizations and take the learnings to respond to future calls on (cross border) rapid diagnostics value-based PPI calls.
